FBU TELLS WILTSHIRE AUTHORITY: PLANS ARE "UNFIT FOR PURPOSE"!



"UNSAFE" PLANS MUST BE WITHDRAWN SAYS UNION!

The FBU has demanded the withdrawal of plans that the Union says will cut the frontline operational capability of Wiltshire Fire & Rescue Service.

The Union has submitted its formal written response to a cuts package put forward by the Service which include cutting the number of Firefighter posts, reducing aerial appliances to only one, removing emergency tenders, halving rope rescue capability, creating 96 hour shifts and massive change to RDS contracts.

Wiltshire FBU Officials handed the submission to political leaders at a meeting of the Fire Authority stating that the cuts should be withdrawn on the basis that they are both "unsafe" and "unfit for purpose". Wiltshire FBU Secretary Brent Thorley said "we consulted widely with members in order to develop our formal response which we believe represents the true voice of professional Firefighters in Wiltshire. We have told the Service that we are willing to enter into a proper and formal dialogue on the issues involved but they should be under no illusion: the FBU will not accept cuts to the frontline Service which compromise public or firefighter safety".

TUC TELLS MP's: NO PAY CUT FOR THE SOUTH WEST

The West Country stands to be relegated to the bottom division of the Chancellor's proposed new pay league, the South West TUC has warned. George Osborne has announced measures to introduce regional pay measures for public servants - a move that would see workers in the South West earn less than their counterparts in other parts of the country.

SW TUC Secretary Nigel Costley said: government claims that by setting lower pay for about a third of the local workforce it will somehow boost the private sector. There is no evidence for this, however, and cutting the earnings of the police, teachers, nurses etc will do nothing but harm to an economy that relies on consumer spending. We call on the region's MPs to oppose this measure, or risk the wrath of working people at the next election."

working people a political voice and that is what I pledge to do. The South West FBU is a Region that



BANNERS FLY IN SUPPORT OF ESSEX FIRE CREWS

Essex Fire Crews started a 24 hour strike on Wednesday 18 July at 0900 until 0900 on Thursday morning. They accuse managers being wholly intransigent, dictatorial and hell bent on confrontation. Delegations Firefighters from across the UK, including members and officials from the South West Region, joined a march



At a rally after the event speakers gave the facts of the dispute:

• Despite currently having £12 million in reserve Essex has cut 100 wholetime FF posts since 2008;



•60 RDS Firefighter posts have been cut since 2008;

•Response times have increased since 2008;

•Back Office staff numbers have increased since 2008;

The dispute in Essex is about stopping further frontline cuts in the emergency service; and they need our help.

With such a belligerent management it is likely that this could be a long dispute which could cause significant hardship unless we all help out. We are asking members in the Region to

FBU RAISE POISONING CONCERNS ON WATER TRAINING COURSES



The FBU has raised concerns after firefighters from various regions suffered sickness during, and immediately after, Swift Water Training.

Training at the Slalom Course at the National Watersports Centre in Nottingham has seen some Firefighters develop serious stomach complaints while others were violently ill with vomiting and diarrhoea.

One recognised complication of acute stomach complaints from water born bacteria is the development of Post Infective Irritable Bowel Syndrome (IBS).

The water on the course is diverted directly from the River Trent and is suspected to be infected by Campylobacter, the bacteria which causes food poisoning. The nature of the course means the firefighters are submerged for long periods of time and have to undertake arduous swimming during the exercise.

Consequently they can inadvertently consume large quantities of water and develop stomach cramps, diarrhoea and vomiting. They can go on to develop IBS, a lifelong condition, which can be managed but not cured.

Thompsons solicitors have advised the FBU that Swift Water Training Courses, whilst essential, need to be safe. In order to provide a safe environment for the training it is essential that the organisation carries out a pre-training assessment of the venue and the water to ensure it is fit for the purpose of training which involves submersion and the likely ingestion of the water. Such assessment would include testing water samples, stopping courses going ahead if they knew about the sickness outbreaks during previous courses and asking the venue to confirm if any sickness had occurred at the venue previously.

FBU Regional Secretary Phil Jordan said: "When firefighters have to perform specialist training they rightly expect that their health and safety is fully considered before being exposed to potentially dangerous situations. If they are being poisoned doing this type of training then they are being badly let down by training providers, their employer and the centre itself. FBU Officials are currently working closely with legal experts and will be raising our concerns with Brigade managers."

"If any FBU member who has been on this course believe that they have been made ill as a result then they should contact the FBU without delay."

Kevin Digby from Thompsons Solicitors added: "Our experts are clear that the poor quality of the water in the Slalom Course can cause infection and that the primary mode of infection was ingestion whilst swimming. Given the arduous nature of the course and the long periods of submersion it is no surprise that these members consumed large quantities of this water. With this knowledge any employer sending staff to train in these conditions without carrying out a proper risk assessment is showing an appalling disregard for the safety of the course attendees. Clearly there is a risk that such a difficult course would involve the swallowing of the water and this should be considered."

WE WON'T BE FOOLED INTO DELIVERING CUTS!

The TUC has recently exposed statistics which will create anger and concern for all of us who live and work in the South West

The figures, from the Office of National Statistics, show that an incredible one in 14 public sector workers in our Region lost their jobs between July and September last year. This means that a total of 37,000 workers - at 7%, the largest fall in the country - employed in the Region by local government, the police, the forces and the NHS lost their jobs. All of this at a time when finding work has never been harder.

As Firefighters we understand that behind every job loss is not just the job consequences but the loss of vital public services. Ministers must see that their economic policies are doing huge harm with public servants being chucked on the scrap heap and the public denied vital services that they once provided.

Our anger at this situation is made worse by some local Fire Service bosses and politicians who seem to be exploiting the economic climate as an excuse to force through damaging cuts in duty systems and working conditions. The Union has received reports from members who apparently have been told by unscrupulous bosses that they should consider themselves "lucky to have a job" and "accept the need for change" by bosses

proposing cuts. The plan seems to be to scare Firefighters into meekly accepting damaging cuts in order to save our own skins.

Tactics such as this aren't just totally unacceptable, they are also insulting to our profession and we reject them entirely.

Politicians who think that we can be frightened into selling out each other's jobs or conditions clearly don't understand Firefighters or our profession.

We have to send a clear message to any Fire Authority who deliberately cuts its own budget and then expects Firefighters to pay for it through job cuts or longer working hours: **you have** a fight on your hands!

Firefighters will not be made culpable for budget cuts not of their making; they must not be made to work longer in order to deliver and hide job cuts or see their conditions and pay reduced due to sheer political opportunism.

You will see in this bulletin that the South West FBU is fighting back for its members in every possible way. We have deployed professional consultations, political engagement, expert lawyers and Union solidarity to fight for and protect FBU members; and we will not stop.

Ours is not a "job that we are lucky to have", it is a skilled, professional vocation which delivers a life saving emergency service. We value our Service and we will not be fooled into helping destroy it through cuts.

Our message is clear: the FBU opposes cuts in the frontline Fire & Rescue Service and we will fight against them in any way necessary. If any politician doubts this then they should visit Essex. *Tam McFarlane*
